427 Transportation Corridor
Environmental Assessment (EA) Study

THE STUDY

The Ontario Ministry of Transportation (MTO) is working to provide for the efficient movement of people and goods within the context of the province's *Growth Plan for the Greater Golden Horseshoe*. In order to realize the transportation objectives of the *Growth Plan for the Greater Golden Horseshoe*, MTO is completing an Environmental Assessment Study (EA) for the *427 Transportation Corridor* that supports the Growth Plan.

The EA will address existing and short-term transportation problems related to the present Highway 427 terminus at Regional Road 7, truck traffic to and from the CPR Vaughan Intermodal Facility, and interregional traffic on Highways 7, 27 & 50. The primary objective is to address transportation issues in the area south of the Greenbelt and to facilitate planning and development.

THE PROCESS

The EA is being undertaken as an Individual Environmental Assessment under the *Ontario Environmental Assessment Act* (OEAA). It is being conducted in accordance with the planning process documented in *The 427 Transportation Corridor Environmental Assessment Terms of Reference*, which was approved by the Minister of the Environment in November 2005. This document provides a framework to guide the preparation of the subsequent EA.

PUBLIC INFORMATION CENTRE

Public input is encouraged throughout the EA. Input is being facilitated through the project website (www.427corridor.com) and a series of Public Information Centres (PICs).

The second PIC has been arranged to allow members of the public and residents an opportunity to review the study process, activities undertaken since the first PIC, assessment and evaluation of alternatives, recommended alternatives and next steps in the study. You are encouraged to attend the PIC and to provide us with your comments so they can be addressed as the project progresses.
