427 Transportation Corridor Environmental Assessment (EA) Study

The Ontario Ministry of Transportation (MTO) has submitted the Environmental Assessment Report (EA Report) for the 427 Transportation Corridor Environmental Assessment Study to the Ontario Ministry of the Environment (MOE) for formal review as required under the Ontario *Environmental Assessment Act*. The EA Report identifies the study's preferred alternative and documents the study process, findings and consultation completed. The preferred alternative includes the extension of Highway 427 6.6 km northerly from Highway 7 to Major Mackenzie Drive and property protection for a Transitway along the west side of the highway.

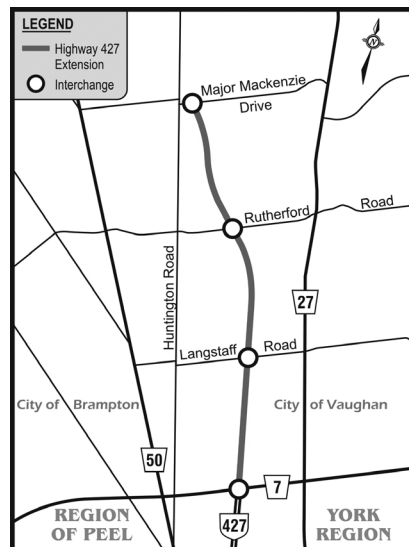
